ANNEXURE-I

TERMS & CONDITIONS

1. **Time for placement of Truck :-** The truck will have to be placed for loading at above mentioned location within 24 hours of receipt of our intimation for the same. The placement of truck at loading point at **Bhilai Talpuri Intl.Colony (C.G.)** will be in the of second week of **June** . The date for loading will be intimated later.
2. **Delivery :-** The goods must be delivered in good condition without causing any damage during loading/unloading/transportation. Please state your earliest delivery period in your offer after loading of house hold goods.
3. **Loading/ Unloading :-** Loading at original point and unloading at destination will have to be carried out by the transporter at their own cost by providing requisite number of labours.
4. **Lacing & Covering :-** Suitable lacing and covering of the goods for protection from rain shall be transporter's responsibility.
5. **Transshipment :-** Transshipment of goods will not be allowed.
6. **Validity of Rates :-** The rate(s) quoted should be valid for a minimum period of **90 days** from the date of opening of the quotation.
7. **Firm rate :-** The rate(s) quoted should remain firm till execution of the order. Offer with escalation of rate shall be summarily rejected.
8. **GST:-** Tenderers are requested to provide GST details as per **Annexure- II & III** and also mention the percentage of GST applicable separately & the rate should be quoted exclusive of GST.
9. **GST Registration :-** Tenderer shall ensure that their GST Registration and GST No. is valid and active at the time of opening of the tender.

If in case the GST status is found invalid & not active, their offer is liable for rejection.
10. **Detention charges :-** No detention charges will be payable by us.
11. **Inter State Road Permit :-** The truck engaged should have interstate road permit required for reaching the destination.
12. **Payment :-** No advance payment shall be made. Full payment shall be made within **30 days** from the date of receipt of your bill along with supporting consignment note duly certified by the owner of the goods regarding receipt of goods in good condition.
The payment shall be made to the tenderer only after the safe receipt of the goods at the destination and submission of proof of safe delivery, duly receipted by the consignee, together with receipts/bills towards payment of Toll Taxes at various Toll Gates falling on the way from the place of commencement to the destination.

13. **Banker's Details :-** Tenderers are requested to state **Banker's Name, Branch, Account No., PAN No. & IFS Code** for remittance of payment though NEFT/RTGS.
14. **Place of Supply & Bills :-** The place of supply of material/services and place of submission of bill should be one and same i.e. Billed to & shipped to should be one and same. Tenderer should submit GST return mentioning the GST number of the State where the material has been supplied or services has been provided.
- "The party has to submit GST Compliance Invoice & in case Liquidated damage is applicable, then GST on Liquidated damage will also be recovered from the party".*
15. **Liquidated Damages :-** Penalty @ $\frac{1}{2}\%$ per week of the value of the order shall be charged for delay in delivery beyond the scheduled delivery period, subject to a maximum of 5% of the value of the order. Proportionate penalty for delay for part of a week shall also be payable by you. The penalty falling due shall be recoverable from the successful tenderer. Your offer shall be rejected if this Liquidated damages clause is not accepted.
- However, L.D. is exempted on account of force majeure conditions i.e., Lockout, Strike, Transporter's strike, Riot, Civil War, Restrictions imposed by Govt. and acts of God like Flood, Earthquake, Fire etc. which are beyond the successful tenderer control.
16. **Risk purchase :-** In the event of transporters failure to execute the work order in accordance with the provision thereof, FSNL reserves the right to get the work done through any alternate agency at the risk and cost of the transporter and to recover from the transporter the entire amount of extra expenditure incurred in connection with the execution of work through an alternative agency from money due or that may become due to the transporter without prejudice of any other right or remedy available to him. Besides being liable for payment of compensation of as stated above, the transporter may be debarred from undertaking any work order from FSNL for such period as may be decided by FSNL.
17. **Security & safety of consignment :-** The transporter will be fully responsible for security & safety of the consignment.
18. **Environment, health and safety of the organization :-** The execution of the job against this order should not adversely affect the environment, health and safety of the organization.
19. **MSME :-** Tenderer(s) falling under MSME category and having valid registration certificate with NSIC, are required to submit registration certificate to enable us to consider under MSME, so that applicable benefits/facilities shall be provided as per procurement policy of Government of India.

ANNEXURE-III

Following undertaking is to be provided by Contractor/ vendor's at the time of submission of quotation :-

1.
